CONDITIONS OF PLAY

By participating in Pickleball at Crown Melbourne ('Crown') you (the 'Participant') expressly agree to be bound by these Conditions of Play. Please carefully read these Conditions of Play before participating in Pickleball.

Crown reserves the right to amend these Conditions of Play, with any changes becoming effective upon posting. Your continued participation in Pickleball constitutes acceptance of the amended Conditions of Play.

IMPORTANT INFORMATION

Participation in Pickleball may have varying effects on individuals. It is your sole responsibility to determine whether you are physically capable of taking part in this exercise and to consult a physician if you are unsure or have not exercised recently.

If you have any medical problem(s) or condition(s) that may be aggravated by exercise, you are recommended to not take part in Pickleball.

Participants must adhere to the following rules:

- Appropriate attire is required at all times such as runners or athletic shoes and they must be non-marking shoes.
- High heels of any sort are strictly prohibited. Any damage to Crown property caused by such footwear will be on-charged to the participant(s).
- Follow Crown staff directions at all times.
- No child under 10 allowed without adult supervision.
- The following items are prohibited from being brought onto the Crown Court: alcohol, glass and breakable objects.
- Animals are prohibited (except for assistance dogs).
- No offensive language or disruptive behaviour.
- Use allocated storage for personal property and do not leave unattended.

Participants who fail to adhere these Conditions of Play (including the above rules), may result in refusal of entry/participation in Pickleball or eviction. Participants will also have their ticket cancelled and will not receive a refund.
